We John Rogers & Josiah Rogers being the executors of the will & last Testament of our honored father, Noah Rogers, late of Branford said, have set out unto our mother Elizabeth Rogers widow of aforesaid Noah Rogers the third part of the fourth division set over a place commonly called Sea Hill upon the west of the lot running, thirty six rods and an half northly from the southerly (covered land ?) from thence fifth three rods and a half east and west cross the lot which third part of ye lot was willed unto the widow during her life, fifty ye 2 & 1729/30 recorded, John Rogers & Josiah Rogers
